Dear Shareholders,

The board of directors of the Company (the "Board") would like to announce to the shareholders of the Sub-Fund the following changes:

**1. Appointment of Amundi Japan Ltd as Investment Manager:**

Amundi Japan Ltd ("Amundi Japan") will be appointed as Investment Manager of the Sub-Fund in replacement of Amundi Asset Management as from **the opening on 15 November 2022** (the "Effective Date").

Amundi Japan is a Japanese regulated company, subject to the rules enacted by the Japanese Financial Services Agency ("FSA") and duly licensed as a financial services agency under reference Kanto Local Finance Bureau (FIBO) n°350 – 9010001062807.

The Board, the Company and Amundi Asset Management consider that Amundi Japan has the relevant resources and expertise to manage the portfolio of the Sub-Fund and that this change should be in the best interest of the Shareholders in the Sub-Fund.

The change of Investment Manager will not have any material impact on the way the Sub-Fund is managed and will not entail any changes to the investment strategy, risk-reward profile, other service providers or any other characteristics of the Sub-Fund, including the level of fees charged to the Sub-Fund or the Company.

The costs associated with the change of Investment Manager will be borne by the Management Company.

**2. Change of name and name of the classes of shares of the Sub-Fund:**

As an on-going effort of improvement of its range, the Management Company wishes to rename the Sub-Fund and the classes of shares of the Sub-Fund as follows:
